**Monthly Service Fee(s)** will commence once the District installs the water meter. Monthly Service Fee(s) are due and payable upon receipt. If the Monthly Service Fee(s) remain unpaid for a period of more than 60 days, the District will impose late fees and will pursue all legal means to collect unpaid balances. The District reserves the right to discontinue water service, including meter removal for unpaid Services Fees. If Water Service Fees remain unpaid, delinquent fee assessed will be the number of months off times the monthly base rate. The maximum amount assessed will be \$500.

**Water Meter Tampering and Unauthorized Use of Water:** Tampering, altering or bypassing a District water meter is subject to a \$1000.00 fine, and can include discontinuance or termination of water service from the District. Water service from the District is only for authorized stakeholders. It shall be illegal to resell or provide water to any other individual or party.
